As the Bangsamoro Government exercises its self-governance and fiscal autonomy, it continuously ushers in new hope for the constituents in the region creating opportunities vital to the socio-economic development and be at par with the rest of the country.

Anchored in one of the Over-all Development Goals of the Bangsamoro Government "Establish the foundations for an inclusive, transparent, accountable, and efficient governance", the Ministry of Finance, and Budget and Management (MFBM-BARMM), in partnership with the Commission on Audit (COA-BARMM), will be conducting a Four-Day Seminar on Laws and Rules in Government Expenditures (LARGE) in two (2) batches. The 1st Batch is scheduled on February 2-5, 2021 while the 2nd Batch is on February 8-11, 2021. It shall be a full day activity to be held at the Shariff Kabunsuan Cultural Complex (SKCC), BARMM Compound, Cotabato City.

Sponsored by the MFBM, the Ministry deems it necessary to conduct such activity to ensure proper utilization of government resources in view of the recently approved FY 2021 General Appropriations Act of the Bangsamoro (GAAB). The activity also aims to enlighten and provide needed knowledge in the processing or disbursement of funds in accordance with the rules and regulations of the government.

With this, each Ministry/Office is given three (3) to five (5) slots for your personnel who are involved in the processing of claims, disbursements including certifying and approving officers specifically your Accountant, Budget Officer, Procurement Officer, Supply Officer, and/or Cashier. Attached is the list of the Ministries/Offices with their respective schedule and number of participants allotted.

All of the participants are **required** to fill-out the form provided by COA on this site bit.ly/LARGESeminar for pre-registration. Participants **must** pre-register **on or before February 1, 2021**.
