In line with the issuance of Bangsamoro Budget Circular (BBC) No. 2024-001<sup>1</sup>, the Ministry of Finance, and Budget and Management (MFBM) will conduct an Orientation re: Guidelines on the Release of Funds for Fiscal Year (FY) 2024 and Workshop on Budget Execution Documents (BEDs) on **January 22, 2024, 8:00 am – 5:00 pm**. The venue will be announced subsequently.
2. The activity aims to provide the BARMM Ministries, Offices and Agencies (MOAs) clear and concise information regarding these Guidelines, and capacitate them on the filling-up of Budget Execution Documents (BEDs).
3. In this regard, the participation of five (5) key officials and employees, particularly the **Minister or Head of Office, Head of Finance, Budget Officer, Planning Officer and Accountant**, from each MOA in the workshop is required.

Furthermore, the delegates are requested to bring their submitted BEDs No. 1, 2 and 3 as prescribed in the BBC No. 2022-12<sup>2</sup>, and to include other documents such as strategic plans, procurement plan and budget allocation (GAAB). Bringing of **at least one (1) laptop** for the workshop is advised.
