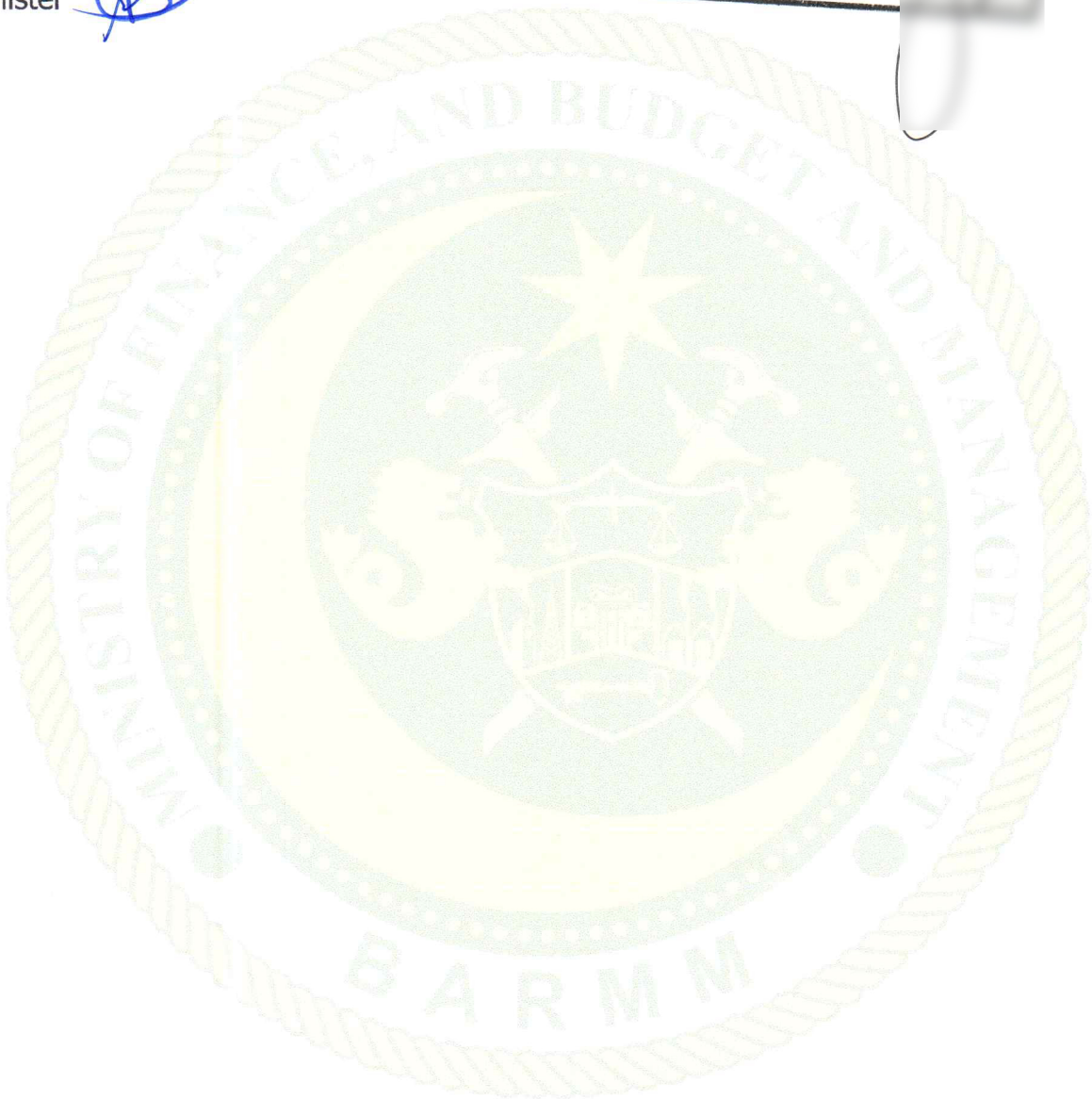
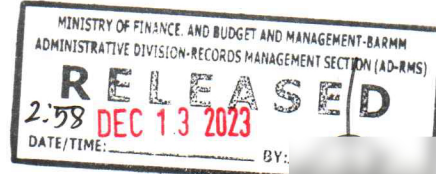
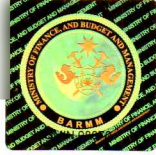
1. In line with the deliberation of the Bangsamoro Expenditure Program for the Fiscal Year (FY) 2024 in the Parliament, the Committee on Finance, and Budget and Management shall be reviewing the physical and financial performances of the Ministries, Offices and Agencies (MOAs).
2. In this regard, the MOAs are required to submit the following Budget and Financial Accountability Reports (BFARs) as of November 30, 2023 for all appropriations, in accordance with the Bangsamoro Budget Circular (BBC) Nos. 2021-03¹ and 2023-08², **not later than December 14, 2023:**
 - BAR No. 1 – Quarterly Physical Report of Operation;
 - FAR No. 1 – Statement of Appropriations, Allotments, Obligations, Disbursements and Balances;
 - FAR No. 1-A – Summary of Appropriations, Allotments, Obligations Disbursements and Balances by Object of Expenditures;
 - FAR No. 1-B – List of Allotments;
 - FAR No. 3-A – Summary of Prior Year's Unpaid Obligations, Disbursements and Balances;
 - FAR No. 4 – Monthly Report of Disbursements;
