: GUIDELINES ON THE RELEASE AND UTILIZATION OF THE LOCAL GOVERNMENT SUPPORT FUND UNDER THE FY 2024 GENERAL APPROPRIATIONS ACT OF THE BANGSAMORO

1.0 LEGAL BASIS

Pursuant to Special Provision No. 1 of the Local Government Support Fund (LGSF) under the FY 2024 General Appropriations Act of the Bangsamoro (GAAB), the amount appropriated for the LGSF shall be available to support the following projects:

- implementation of agriculture-related programs and projects, such as: (a) provision of agricultural support services, including planting materials distribution system and operation of farm produce collection and buying stations; (b) extension of on-site research services and facilities related to agriculture and fishery activities; (c) construction, restoration and improvement of infrastructure facilities, including farm-to-market roads, slaughter houses, small water impounding projects, fishports, and water supply systems; and (d) provision of various production inputs for crops, livestock and poultry, and fisheries;
- Information and Communications Technology systems and infrastructure development, such as, but not limited to, establishment of Integrated Business Permit and Licensing System, and digitalization of payments for collections and disbursements;
- iii) construction, maintenance, development, and/or rehabilitation of the following projects: (a) green open spaces such as public parks and plazas, arboretum, botanical gardens, and nature and family park; (b) infrastructure for active mobility, such as physically separated bicycle

lanes, bike racks; (c) elevated or at-grade pedestrian footpaths and walkways; and (d) multi-purpose building;

- iv) implementation of programs, projects and activities for disaster response, rehabilitation, and recovery, including procurement or acquisition of disaster equipment and vehicles for disaster response and rescue activities;
- v) acquisition of school sites;
- vi) purchase of ambulance, trucks, or mini-dump trucks; and,
- vii) assistance to indigent individuals or families in any of the following forms: (a) medical; (b) burial; (c) transportation; (d) food assistance; and (e) educational assistance/scholarship.

The amount appropriated shall also be available to provide financial subsidy to the newly created Municipalities in the Special Geographic Area (SGA) of the BARMM (Municipality of Pahamuddin, Municipality of Kadayangan, Municipality of Nabalawag, Municipality of Kaabakan, Municipality of Kapalawan, Municipality of Malidegao, Municipality of Tugunan, and Municipality of Ligawasan) and other Local Government Units (LGUs) that may be created by the Bangsamoro Transition Authority (BTA) Parliament. Provided, that the financial subsidy to the newly created municipalities shall only be available until such time that the Municipality has been allocated its share in the national tax allotment.

The release and disbursement of the aforementioned financial subsidy shall be subject to usual accounting and auditing rules and regulations.

2.0 PURPOSE

This Circular is being issued to prescribe the guidelines and procedures on the release and utilization of the LGSF in accordance with the special provisions under XXXIV. LOCAL GOVERNMENT SUPPORT FUND of the FY 2024 GAAB.

3.0 COVERAGE

This Circular covers all constituent LGUs under the jurisdiction of the Bangsamoro Government in accordance with the Bangsamoro Organic Law.

4.0 GENERAL GUIDELINES

4.1 The LGSF shall be exclusively used by the beneficiary provinces, cities, municipalities, and barangays to fund the eligible programs and

projects enumerated under SP No. 1, purpose no. i to vii, and the financial subsidy to newly created LGUs under item viii of the LGSF under the FY 2024 GAAB. For the guidance of the LGUs, the definition of terms covering the scope of eligible programs and projects are provided in Annex A hereof.

- 4.2 The LGSF shall be available for obligation and disbursement for the purposes specified until fully expended consistent with SP No. 3 of GAAB FY 2024.
- 4.3 All Special Budget Requests (SBRs) chargeable against the LGSF shall be signed by the Local Chief Executive (LCE) of the province, city, municipality, or barangay, and shall be addressed to the Office of the Chief Minister of the BARMM copy furnished to the Ministry of Finance, and Budget and Management (MFBM).

As such, the LGUs shall directly submit their SBRs, together with the documentary requirements prescribed under this Circular, to the Office of the Chief Minister.

- 4.4 All SBRs of LGUS, especially those covering multiple projects, shall be subject to the evaluation by the MFBM prior to the approval of the Chief Minister, based on necessity and fund availability.
 - 4.4.1 LGUs receiving financial subsidies from the National Government may still avail of the LGSF, provided that they submit information to the MFBM as to the amount(s) that they have received from the National Government as well as the projects funded, as additional attachments to the SBR.

For this purpose, the said LGUs shall also submit to the MFBM the Fund Utilization Report.

- 4.5 For the financial subsidy that will be requested by the newly created Municipalities, pending the release of their share from the national tax allotment (NTA), the amount shall in no case exceed the average NTA received by a 6th Class Municipality in the Bangsamoro Autonomous Region (BAR).
- 4.6 In order to ensure that funds from the LGSF are released to the LGUs within the fiscal year, the final deadline for the submission of requests shall be on or before **December 15, 2024**.

- 4.7 To preclude unscrupulous individuals or organized groups from making representations that they are able to influence or facilitate the release of the LGSF, the MFBM shall directly deal only with the LCE or his/her authorized representative as specified in the SBR. The authorized representative must be an organic personnel of the LGU.
 - 4.7.1 In order to avoid disclosure of valuable information to unauthorized individuals, the MFBM shall refrain from divulging the status or details of fund releases in case of phone inquiries.
 - 4.7.2 Inquiries made through electronic mail are also discouraged, but certain queries may be entertained, provided that the sender has established the veracity of his/her identity through the submission of a copy of his/her LGU identification card, showing that he/she is either the LCE or the authorized representative of the LGU.
- 4.8 In case of infrastructure projects, the beneficiary LGUs shall observe and comply with the requirements on the implementation of infrastructure projects pursuant to Section 21 of the General Provisions of the FY 2024 GAAB.

Furthermore, the beneficiary LGUS shall ensure that the designs of all proposed projects for the construction, rehabilitation, repair, or improvement of government buildings, public market, and school sites include the installation of a Rainwater Collection System, in accordance with the prescribed design of the Ministry of Public Works, pursuant to Section 22 of the General Provisions of the FY 2024 GAAB.

- 4.9 The purchase of motor vehicle(s) shall be subject to the Administrative Order No. 14, s. 2018 and the guidelines issued by the MFBM and other applicable laws.
- 4.10 The Ministry of the Interior and Local Government (MILG) shall be responsible for the monitoring and evaluation of actual project implementation of LGUs. The MFBM shall provide the MILG with a list of releases from the LGSF to LGUs for monitoring and evaluation purposes.

The beneficiary LGUs shall comply with the guidelines that may be issued by the MILG for the monitoring and evaluation of actual implementation of projects, including the submission of the

- necessary plans/documents relative to the project design/preparation.
- 4.11 Disbursement and utilization of funds by the LGUS shall be subject to pertinent provisions of the Government Procurement Reform Act (RA No. 9184) and its 2016 Revised Implementing Rules and Regulations (IRR), and any relevant policies issued by the Government Procurement Policy Board (GPPB), as well as, the applicable budgeting, accounting, and auditing rules and regulations.

5.0 SPECIFIC GUIDELINES

- 5.1 The LGUs shall ensure that their SBRs have been properly endorsed and substantially comply with the following documentary requirements to merit evaluation:
 - 5.1.1 SBR/Letter of Intent, signed by the LCE of the requesting LGU, following the template prescribed in Annex C hereof;
 - 5.1.2 In case of requests for purchase of motor vehicles, the following documents shall also be submitted:
 - 5.1.2.1 Project Profile for Motor Vehicles, following the template prescribed in Annex D hereof; and
 - 5.1.2.2 Inventory of Motor Vehicles, following the template prescribed in Annex E hereof.
 - 5.1.3 Report on Fund Utilization for any previous releases funded by the National Government, following the template prescribed in Annex B hereof.
- 5.2 All required information, format, and signatories in the documentary requirements under this Circular and its annexes shall be completely provided by the LGUs. Failure to comply with any of the said requirements shall be a ground to deny the request of the LGU.
- 5.3 Other documents submitted by the LGUs that are not among the prescribed documentary requirements under this Circular may form part of the evaluation of the MFBM.
- 5.4 It is understood that only requests prepared, signed, and submitted by the LCEs shall be evaluated by the MFBM. Requests that are shown

to have been prepared and/or submitted by third parties, e.g., fixers, middlemen, and facilitators, shall be immediately denied.

- 5.5 The LGU shall ensure that no duplication of funding will occur. As such, the LGU, through its LCE, shall immediately inform MFBM if it has received funding from other sources for the same programs or projects.
- 5.6 Upon receipt of the SBRs, the MFBM shall:
 - 5.6.1 Check compliance with the documentary requirements submitted by the LGUs and may return the same immediately in the event that the documentation required is incomplete.
 - 5.6.2 Conduct evaluation of the fully compliant SBRs and render appropriate action thereon.
- 5.7 The Special Allotment Release Order (SARO) and the Notice of Cash Allocation (NCA) shall be released to the LGU by MFBM thru the Bangsamoro Treasury Office (BTO).

Upon receipt of the SARO and Notice of Cash Allocation (NCA), the BTO shall release the corresponding Advices to Debit Account (ADAs) to the Authorized Government Servicing Banks (AGSBs) of the beneficiary LGUs. In parallel, the BTO shall inform the said LGUs of the released funds and their purposes through the issuance of Notice of ADA Issued (NADAI).

5.8 The MFBM, through the Bangsamoro Budget Office, shall send Confirmation Letters to the LCEs concerned to provide them details of the funds released immediately after issuance of the fund release documents. This Confirmation Letter shall also serve as the Authority to Purchase Motor Vehicle (APMV), in the event the approval includes purchase of motor vehicle.

The issuance of APMV for motor vehicles under the project menu of the LGSF that fall within the authority of the MILG shall remain with the MILG, consistent with AO No. 14.

5.9 The LGSF shall be recorded as a trust account in the general fund by the LGUs for the specific purpose(s) for which the funds were received. The amounts released to the LGU from the LGSF shall be

available for obligation and disbursement for the purpose specified until fully expended.

However, if at any point the LGU determines that the funds can no longer be utilized, e.g., when the program(s) and/or project(s) cannot be implemented for any reason or when the same has/have been funded from other sources, the amount received by the same LGU from the LGSF shall be immediately reverted to the Bangsamoro Treasury.

6.0 LIMITATIONS ON THE USE OF THE LGSF

- 6.1 The LGSF to LGUS shall only be used:
 - 6.1.1 For the purpose the program(s) and/or project(s), including the location thereof, for which the fund was released; and
 - 6.1.2 For the purchase of motor vehicles with specifications, costs, deployment, and/or purpose as specified in the APMV in the form of Confirmation Letter issued by the MFBM to the LGU. Any change in the specification and cost shall require prior evaluation and approval of the MFBM.
- 6.2 In no case will the LGSF be used for:
 - 6.2.1 Projects already fully covered by other sources of funds; and
 - 6.2.2 Payment of Personal Services expenditures (i.e., payment of salaries, including honoraria, allowances, bonuses, and similar forms of compensation).

7.0 POSTING AND REPORTING REQUIREMENTS

The beneficiary LGUs shall:

- 7.1 Comply with the posting requirements prescribed under RA No. 9184 and its 2016 Revised IRR, and all relevant policies issued by the GPPB;
- 7.2 Prepare quarterly reports on fund utilization and status of program/project implementation using the prescribed format (Annex B) and submit the same to MILG & MFBM.

- 7.3 Consistent with the government's Full Disclosure Policy, the LGU shall post the said reports in at least three (3) conspicuous public places in the locality and on the LGU's website within thirty (30) calendar days from the end of each quarter.
- 7.4 Send a written notice, through the LCE, together with a copy of the said reports, to the Office of the Chief Minister, MFBM Minister, and the MILG Minister upon posting of the reports on the LGU's website, if any. The date of notice to said Ministries and Offices shall be considered the date of compliance with the requirement.

8.0 RESPONSIBILITY AND ACCOUNTABILITY

The responsibility and accountability in the implementation of programs and projects, and proper utilization and disbursement of the LGSF shall rest upon the LCE and other local officials concerned of the recipient LGU. It is also the responsibility of said local officials to ensure that the funds released to the LGU are utilized strictly in accordance with applicable laws, rules and regulations.

9.0 ITEMS FOR RESOLUTION

Interpretation of the provisions of this Circular, including relevant items not covered herein, shall be referred to the MFBM for resolution.

10.0 SEPARABILITY CLAUSE

If any provision of this Circular is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid and subsisting.

11.0 REPEALING CLAUSE

All provisions of existing guidelines that are not consistent with this Circular are hereby revised, modified, and/or repealed accordingly.

12.0 EFFECTIVITY

This Circular shall take effect immediately after its publication.
