**BANGSAMORO TREASURY CIRCULAR**

SUBJECT : **CANCELLATION OF TAX IDENTIFICATION NUMBER (TIN) OF AGENCIES UNDER THE THEN ARMM GOVERNMENT**  
DATE : **14 JUNE 2022 | 15 Dhul Qidah 1443 AH**

1. The Bureau of Internal Revenue (BIR) has established a computerized system which automated the monitoring of compliance of all taxpayers with registered Tax Identification Numbers (TIN). Taxpayers identified to have discontinued payment of taxes are tagged as open cases which will be automatically charged with surcharges. To avoid this, businesses, offices, or agencies whose juridical existence has terminated by virtue of dissolution, merger, or consolidation are required to process cancellation of their TIN.
2. Relative thereto, the BIR notified the Ministry about the existence of tax liabilities for surcharges resulting from the identified non-filing of mandatory tax returns and non-remittance of taxes withheld by the agencies under the then ARMM Government.
3. To eliminate further imposition of surcharges, the Heads of the Ministries, Agencies, and Offices are requested to identify the agencies under the previous regional government which were deemed abolished upon the ratification of the Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM).
4. The Ministries, Agencies and Offices shall immediately submit application for TIN cancellation to BIR and all other documentary requirements to support the application for cancellation. Upon successful cancellation of TIN, we request that the MFBM, through the Bangsamoro Treasury Office, be notified.
5. By virtue of Section 236 of the National Internal Revenue Code (NIRC) and Revenue Regulation No. 11-2008, the Heads of the Ministries, Agencies and Offices (MOAs) are personally charged with duty to secure TIN for their respective M/O/A.
