BANGSAMORO TREASURY CIRCULAR

TO: ALL MINISTRIES AND OFFICES
Bangsamoro Autonomous Region in Muslim Mindanao

SUBJECT: DESIGNATION OF PERMANENT BANGSAMORO COLLECTING OFFICER PER MINISTRY/ OFFICE/ AGENCY

DATE: 10 SHAWWAL 1444 AH/ 2 MAY 2023

1. Pursuant to Section 3, Chapter 1, Book VII of the Bangsamoro Autonomy Act No. 13 also known as the Bangsamoro Administrative Code, fees, charges, levies, taxes, dues, and other income collected and received by income-generating agencies and GOCCs of the BARMM shall be remitted to the account of the Bangsamoro Treasury Office (BTO). The manner and regularity of remittance shall be in accordance with existing laws, rules, and regulations relative thereto.
2. As part of the implementation of the above-mentioned provision, and to effectively monitor and ensure regular remittance of collection of regional taxes, fees, and charges from income-generating Ministries/Offices/Agencies (M/O/As), the BTO shall establish the Official List of Bangsamoro Collecting Officers. The Bangsamoro Collecting Officers, as designated accountable officers per M/O/A, shall be responsible for the collection and deposit to the Bangsamoro Treasury of the regional taxes, fees and charges mandated by existing laws to their respective M/O/As.
3. Anent this, all heads of ministries, agencies, and offices are hereby directed to designate official collecting officer/s and submit their names to BTO including the following information:
 - a. Name of Collecting Officer;
 - b. Position;
 - c. Status of Employment;
 - d. Official Station; and
 - e. Contact Number/ Email
4. The collecting officers as accountable officers shall be properly and regularly bonded with the Bureau of the Treasury, submit monthly reports of collections and deposits to the BTO, and his/ her collection performance may be monitored based


on his/ her submitted reports. Moreover, capacity building may also be provided if necessary.

- 5. Please submit the above information to BTO on or before June 2, 2023 in hardcopy.
