In line with the issuance of the F.Y. 2024 Budget Call, the Ministry of Finance, and Budget and Management (MFBM) shall conduct the **Bangsamoro Budget Forum for F.Y. 2024** on **Tuesday, March 14, 2023, 8:00 am** at the **Shariff Kabunsuan Cultural Complex (SKCC), Bangsamoro Government Center Cotabato City**.
2. The key discussions will revolve around the guidelines on the preparation of F.Y. 2024 budget proposals of the Ministries, Offices and Agencies (MOAs) as well as the indicative Bangsamoro Budget Calendar.

The Bangsamoro Budget Forum for F.Y. 2024 shall enable the MOAs to be informed on the F.Y. 2024 Budget Call Guidelines and the highlights of the budget preparation, as well as ensure that the plans, programs, activities and projects of the MOAs are aligned with the policies and priority agenda of the Chief Minister and the Bangsamoro Development Plan (BDP) 2023-2028.
