1. In view of the organizational alignment toward operational efficiency and pursuant to **Section 10, Chapter 4, Title IV of the Bangsamoro Autonomy Act No. 13**, otherwise known as the **Bangsamoro Administrative Code** which provides that **"The Bangsamoro Treasury Office shall act as principal custodian of financial assets and real properties of the Bangsamoro Government"**, this office is reiterating the handover of original legal documents of all real properties under BARMM as stated in **MFBM Circular Letter No. 2022-07 dated February 8, 2022** and **MFBM Circular Letter No. 2022-12 dated March 4, 2022**.
2. Anent this, all ministries, agencies and offices that have not yet complied with the said circular are hereby directed to handover the list of all their real properties under BARMM with its corresponding original legal documents on or before **April 12, 2023**.


1. Pursuant to Section 10, Article XVI of Republic Act No. 11054 or the Organic Law for the Bangsamoro Autonomous Region in Muslim Mindanao, provides that *"All powers, functions, asset capital, records, funds, receivables, equipment, and facilities of the Autonomous Regional Government in Muslim Mindanao at the time of the ratification of this Organic Law shall be transferred to the Bangsamoro Government, except those properties, land and structures which are located outside of the Autonomous Region in Muslim Mindanao and subject to the conditions as provided in paragraph (d), Section 4 of this Article"*.
2. Section 10, Chapter 4, Title IV of the Bangsamoro Autonomy Act No. 13, otherwise known as the Bangsamoro Administrative Code states that *"The Bangsamoro Treasury Office shall act as principal custodian of financial assets and real properties of the Bangsamoro Government"*.
3. To effectively implement the said mandates, the Bangsamoro Treasury Office needs to consolidate all existing real properties of BARMM ministries, agencies and offices.
4. Anent this, all heads of ministries, agencies and offices are hereby directed to handover the list of all the real properties under BARMM with its corresponding original documents.
5. Submission must be made in hardcopy to the Bangsamoro Treasury Office on or before February 18, 2022.
