SUBJECT : **ATTENDANCE TO THE SEMINAR-WORKSHOP ON BANGSAMORO BUDGET EXECUTION GUIDELINES**

DATE : **14 JANUARY 2021 | 30 JUMADA AL-AWWAL 1442 AH**

1. To initiate the execution phase of the Bangsamoro Budget Process, the Ministry of Finance, and Budget and Management will be releasing the 2021 Budget Execution Guidelines (BEG). The BEG is purposely crafted to contain the guidelines, rules and procedures in the release, implementation and monitoring of the enacted Fiscal Year 2021 Bangsamoro Appropriations.
2. With this, the MFBM will be conducting a one-day seminar-workshop on **January 18, 2021 at Shariff Kabunsuan Cultural Complex (SKCC)** to orient the Ministries/ Offices on the salient features of the BEG and to capacitate the proper filling-up of Budget Execution Documents (BEDs) attached therein.
3. Anent this, each Ministry/ Office is enjoined to send five (5) pertinent employees which includes the budget officer, planning officer, accountant, supply officer and head of finance services/ division in attending the said Seminar-Workshop. List of participants must be submitted on or before January 15, 2020 to budgettechnical.mfbm@gmail.com
4. Furthermore, the delegates are requested to bring their draft Budget Execution Documents (BEDs 1-3) as provided in the Bangsamoro Budget Circular No. 2021-01, and to include other documents such as strategic plans, procurement plan, and budget allocation (GAAB). Furthermore, each Ministry/Office must have at least one laptop for the workshop and simulation.
5. In compliance with the IATF requirements, we are requiring all delegates to observe the minimum health standards in the duration of the activity. Your usual cooperation such as wearing of masks and observation of social distancing will be highly appreciated.
