- 1. To prescribe the structural, functional and procedural principles and rules of governance of the Bangsamoro Autonomous Region, the Bangsamoro Parliament enacted the Bangsamoro Administrative Code (BAA No. 13) on October 28, 2020.
- 2. Among the prominent features of the Bangsamoro Administrative Code (BAC) is the creation of various offices, bureaus, and boards as well as providing for their organizational structures.
- 3. Furthermore, the enactment of the 2021 General Appropriations Act of the Bangsamoro (BAA No. 15) last December 23, 2020, provides for the necessary funding requirements for the full implementation of the BAC, subject to the budgeting rules and guidelines set forth by the MFBM on Personnel Services.
- 4. Anent this, all newly created offices/ bureaus are enjoined to submit their proposals for Personnel Services funding to the MFBM thru submission of the following documents:

 - B. Legal Basis
 - C. Rationale for the creation of new organizational structure/ staffing pattern
 - D. Proposed:
 - i. Organizational Structure
 - ii. Functional Statements (by organizational unit)
 - iii. Staffing pattern:
 - Number of positions
 - Position title/ salary grade
 - Functions/ duties/ responsibilities of the positions
 - E. Detailed computation of the Personnel Services (PS) cost (Annex A)
- 5. All documents must be submitted on or before **17 March 2021** in both hard and soft copies and duly signed by the head of office.
