- 1. In line with the ongoing formulation of FY 2025 budget levels, the Ministry of Finance, and Budget and Management (MFBM) shall conduct the Technical Budget Hearings (TBH) for the submitted FY 2025 Tier 2 budget proposals of the Ministries, Offices, and Agencies (M/O/As) starting May 6, 2024 at the MFBM Conference Room, 3rd Floor, MFBM-BARMM Bldg., Bangsamoro Government Center, Gov. Gutierrez St., Cotabato City.
- 2. The TBH shall cover both new and expanded programs and projects based on the Bangsamoro Budget Preparation (BBP) Forms submitted.
- 3. The following guidelines shall be observed by the M/O/As in the conduct of the FY 2025 TBH:
 - 3.1. Modality and Schedule:
 - 3.1.1. The activity shall be conducted in a physical setup.
 - 3.1.2. The TBH for the M/O/A shall be conducted shortly after the Directives, Accomplishments, and Performance Assessment Tracking (DAPAT) Meetings. The Office of the Chief Minister (OCM) shall issue a separate memorandum for the latter.
 - 3.1.3. The indicative schedule for the TBH, inclusive of the schedule for the DAPAT Meetings, is attached herein as Annex A.
 - 3.1.4. Only if necessary, a written request for a change in schedule of the M/O/A signed by the Minister/Head of Office shall be made **not later** than April 26, 2024, 5:00 PM. Only the request with valid reason/s shall be considered but subject to the discretion of MFBM.

3.1.5. MFBM shall inform the M/O/A of a change in schedule and/or venue three (3) days prior to their schedule.

3.2. Delegation:

- 3.2.1. Due to the limited capacity of the venue, the delegation of the M/O/A is strictly limited to a maximum of ten (10) members only.
- 3.2.2. The delegation shall be composed of the following:
 - Head of the Delegation: Minister/Head of Office
 - Members of the Delegation:
 - Deputy Minister
 - Director General
 - Head of the Budget Division/Office
 - Head of the Accounting Division/Office
 - Head of the Planning Division/Office
 - Head of Finance or Chief Administrative Officer
 - Head of Human Resource Division/Office
 - Sectoral Heads
 - Heads of Integrated Provincial Health Offices (IPHOs) for the Ministry of Health
- 3.2.3. The duly accomplished and signed list of confirmed attendees of the M/O/A must be submitted **five (5) days prior to their schedule**. This shall be emailed in advance to the MFBM-Budget Technical Division (BTD) at budgettechnical.mfbm@gmail.com. The template is attached herein as Annex B.

3.3. Presentation:

- 3.3.1. The Minister/Head of Office shall present the FY 2025 Tier 2 budget proposal not exceeding 30 minutes.
- 3.3.2. The M/O/A must use the prescribed template of the budget proposal presentation attached herein as Annex C. MFBM shall email the softcopy of the template, along with the scanned copy of this Circular.
- 3.3.3. Ten (10) hard copies of the presentation must be submitted **five (5)** days prior to their schedule.
- 3.3.4. The softcopy of the presentation must be sent through email to the assigned sector of the MFBM Budget Preparation and Execution Division (BEPD) provided in the table below. The same must be copy furnished to the MFBM-BTD through the email provided above.
